Information Items

1. Status of Permit Planning

Water Director Kocher introduced this item and reported that staff has developed a worst case scenario for permitting.

Director Jaffe asked which permit will be the most difficult and what hurdles are anticipated.

Water Director Kocher reported that the Coastal Development Permit will be most difficult and energy is the biggest hurdle. Staff has studied the work that was done by Carlsbad (Poseidon) to obtain a permit for a 50 mgd plant.

No action was taken on this item.

General Business

1. Desalination Project Watershed Sanitary Survey, Results and Next Steps

Water Director Kocher reported that California Department of Public Health (CDPH) requires that a sanitary survey be done in order to determine what contaminants impact source water and determine treatment requirements.

Director B. Jaffe moved acceptance of the Desalination Project Watershed Sanitary Survey for further use in the design of the proposed full-scale desalination plant. Councilmember D. Lane seconded.

A. Work Schedule

The Pilot Study and Watershed Sanitary Study reports are complete.

B. Upcoming Tasks

Both the Offshore Geophysical Study Report and the Intake Feasibility Study Report are in technical review. Staff will be combining the Technical Working Groups into one and it will provide a report to the Regional Water Quality Control Board of the results of the Offshore Geophysical Study and why a subsurface intake is not feasible.

Five proposals were received for design of the full-scale plant. Four firms were invited to interview. Consultant selection and the scope of work will be on the next agenda.

Fourteen agencies have joined CalDesal and scwd² has joined as a public agency member at a cost of \$5,000.

A community forum on the History of Water Planning is scheduled for July 28, 2010 at the Santa Cruz Police Facility. A four-page fact sheet is being developed on with a history and timeline for both agencies.

The questions that were submitted following the last community forum on Conservation have been answered and are available of the scwd² website.

The scwd² website is receiving 700 hits a month. The majority (60%) of visitors are reaching us by typing the web address, 30% are coming in through search engines and 8% percent are being redirected from the City or District website.
